I. Situation Overview

On 02 February 2024 at around 2:00 AM, a fire incident occurred in Brgy. Agdahon, Passi City, Iloilo. The fire was declared out at around 2:58 AM.

One (1) family or **five (5) persons** temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Agdahon, Passi City, Iloilo** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱18,146.00** worth of assistance was provided to the affected families; of which, **₱8,146.00** from **DSWD** and **₱10,000.00** from the **Local Government Unit (LGU)** (see Annex D).
