



DSWD DROMIC Report on the Fire Incident in Brgy. Allangigan, Conner, Apayao

09 February 2024, 6PM

I. Situation Overview

On 19 January 2024 at around 9PM, a fire incident occurred at Purok 3, Brgy. Allangigan, Conner, Apayao.

Relative to the incident, the DSWD through its Field Office in CAR together with the LGU of Conner and PLGU of Apayao, provided relief and financial assistance to support the immediate needs of affected families and individuals.

II. Status of Affected Areas and Population

One (1) family or four (4) persons were affected in Brgy. Allangigan, Conner, Apayao (see Annex A).

III. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Allangigan, Conner, Apayao** (see Annex B).

IV. Cost of Humanitarian Assistance Provided

A total of ₱67,766.40 worth of assistance was provided to the affected family; composed of ₱7,766.40 from DSWD and ₱60,000.00 from the Local Government Unit (LGU) (see Annex C).
