



DSWD DROMIC Report on the Fire Incident in Brgy. Bacong, Guimbal, Iloilo

03 February 2024, 6AM

I. Situation Overview

On 12 January 2024 at around 4:00 PM, a fire incident occurred in Brgy. Bacong, Guimbal, Iloilo.

In response, the DSWD through its Field Office in Region VI and the Local Government Unit (LGU) of Guimbal, provided relief assistance to support the immediate needs of the affected families and individuals.

II. Status of Affected Areas and Population

One (1) family or **five (5) persons** were affected in **Brgy. Bacong, Guimbal, Iloilo** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or **five (5) persons** temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Bacong, Guimbal, Iloilo** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱8,062.00 worth of assistance was provided to the affected families; composed of ₱6,562.00 from DSWD and ₱1,500.00 from the Local Government Unit (LGU) (see Annex D).
