

## **DSWD DROMIC Report on the Fire Incident in Brgy. Bacong, Guimbal, Iloilo**

03 February 2024, 6AM

### **I. Situation Overview**

On 12 January 2024 at around 4:00 PM, a fire incident occurred in Brgy. Bacong, Guimbal, Iloilo.

In response, the DSWD through its Field Office in Region VI and the Local Government Unit (LGU) of Guimbal, provided relief assistance to support the immediate needs of the affected families and individuals.

**One (1) family** or **five (5) persons** were affected in **Brgy. Bacong, Guimbal, Iloilo** (see Annex A).

### **III. Status of Displaced Population**

#### **Outside Evacuation Center**

**One (1) family** or **five (5) persons** temporarily stayed with their relatives (see Annex B).

### **IV. Damaged Houses**

**One (1) house** was **totally damaged** in **Brgy. Bacong, Guimbal, Iloilo** (see Annex C).

### **V. Cost of Humanitarian Assistance Provided**

A total of **₱8,062.00** worth of assistance was provided to the affected families; composed of **₱6,562.00** from **DSWD** and **₱1,500.00** from the **Local Government Unit (LGU)** (see Annex D).
