I. Situation Overview

On 20 February 2024 at around 9:18 AM, a fire incident occurred at Sitio Marketside, Brgy. Balucuan, Dao, Capiz. The fire was declared out at around 10:30 AM.

A total of **two (2) families** or **seven (7) persons** were affected in **Brgy. Balucuan**, **Dao, Capiz** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or three (3) persons temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

A total of two (2) houses were damaged; of which, one (1) is totally damaged and one (1) is partially damaged in Brgy. Balucuan, Dao, Capiz (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱17,028.00** worth of assistance was provided by **DSWD** to the affected families (see Annex D).
