





DSWD DROMIC Report on the Fire Incident in Brgy. Banago, Bacolod City, Negros Occidental

03 February 2024, 6AM

I. Situation Overview

On 27 January 2024 at around 5:03 PM, a fire incident occurred in Brgy. Banago, Bacolod City, Negros Occidental. The fire was declared out at around 7:35 PM.

In response to the incident, the DSWD through its Field Office in Region VI together with the LGU of Bacolod City, promptly provided intervention to support the immediate needs of affected families and individuals through the provision of food and non-food relief assistance.

II. Status of Affected Areas and Population

A total of **two (2) families** or **12 persons** were affected in **Brgy. Banago, Bacolod City, Negros Occidental** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of **two (2) families** or **12 persons** temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was totally damaged in Brgy. Banago, Bacolod City, Negros Occidental (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of \$\mathbb{P}21,871.56\$ worth of assistance was provided to the affected families; composed of \$\mathbb{P}16,871.56\$ from **DSWD** and \$\mathbb{P}5,000.00\$ from the **Local Government Unit (LGU)** (see Annex D).
