15 February 2024, 6AM

I. Situation Overview

On 12 February 2024 at around 12:28 AM, a fire incident occurred in Brgy. Bata, Bacolod City. The fire was declared out at around 1:25 AM.

A total of **two (2) families** or **eight (8) persons** were affected in **Brgy. Bata, Bacolod City** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of **two (2) families** or **eight (8) persons** temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was totally damaged in Brgy. Bata, Bacolod City (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱13,435.78 worth of assistance was provided to the affected families; of which, ₱8,435.78 from DSWD and ₱5,000.00 from the Local Government Unit (LGU) (see Annex D).
