I. Situation Overview

On 12 February 2024 at around 12:28 AM, a fire incident occurred in Brgy. Bata, Bacolod City. The fire was declared out at around 1:25 AM.

A total of **two (2) families** or **eight (8) persons** temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Bata, Bacolod City** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱13,435.78** worth of assistance was provided to the affected families; of which, **₱8,435.78** from **DSWD** and **₱5,000.00** from the **Local Government Unit (LGU)** (see Annex D).
