

DSWD DROMIC Report on the Fire Incident in Brgy. Cabagna-an, La Castellana, Negros Occidental

14 February 2024, 6AM

I. Situation Overview

On 28 January 2024 at around 7:00 PM, a fire incident occurred in Brgy. Cabagna-an, La Castellana, Negros Occidental. The fire was declared out at around 8:15 PM.

One (1) family or six (6) persons were affected in **Brgy. Cabagna-an, La Castellana, Negros Occidental** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or six (6) persons temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Cabagna-an, La Castellana, Negros Occidental** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱10,307.00** worth of assistance was provided to the affected families; of which, **₱5,307.00** from **DSWD** and **₱5,000.00** from the **Local Government Unit (LGU)** (see Annex D).
