I. Situation Overview

On 21 January 2024 at around 10PM, a fire incident occurred in Brgy. Camalongo, Calinog, Iloilo.

In response, the DSWD through its Field Office in Region VI, provided relief assistance to support the immediate needs of the affected families and individuals.
