



DSWD DROMIC Report on the Fire Incident in Brgy. Gayusan, Agno, Pangasinan

04 February 2024, 6AM

I. Situation Overvlew

On 18 January 2024 at around 12:15 PM, a fire incident occurred in Brgy. Gayusan, Agno, Pangasinan. Relative to the incident, the DSWD through its Field Office in Region I, and the Municipal Social Welfare and Development Office (MSWDO) of Agno, Pangasinan, provided relief assistance to support the immediate needs of the affected families and individuals.

II. Status of Affected Areas and Population

One (1) family or **three (3) persons** were affected in **Brgy. Gayusan, Agno, Pangasinan** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or **three (3) person** are temporarily staying with relatives (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Gayusan, Agno, Pangasinan** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱22,077.50** worth of assistance was provided to the affected family; composed of **₱17,077.50** from **DSWD** and **₱5,000.00** from the **Local Government Unit (LGU)** (see Annex D).
