

## **DSWD DROMIC Report on the Fire Incident in Brgy. Haba, Condoni, Negros Occidental**

03 February 2024, 6PM

### **I. Situation Overview**

On 28 January 2024 at around 7AM, a fire incident occurred in Brgy. Haba, Condoni, Negros Occidental. According to the Bureau of Fire Protection (BFP), the cause of fire was allegedly due to faulty electrical wire. The fire was declared out at around 8:48 AM.

**One (1) family** or **four (4) persons** were affected in **Brgy. Haba, Condoni, Negros Occidental** (see Annex A).

### **III. Status of Displaced Population**

**One (1) family** or **four (4) persons** temporarily stayed with their relatives or friends (see Annex B).

### **IV. Damaged Houses**

**One (1) house** was **totally damaged** in **Brgy. Haba, Condoni, Negros Occidental** (see Annex C).

### **V. Cost of Humanitarian Assistance Provided**

A total of **₱9,438.00** worth of assistance was provided to the affected families; of which, **₱4,438.00** from **DSWD** and **₱5,000.00** from the **Local Government Unit (LGU)** (see Annex D).

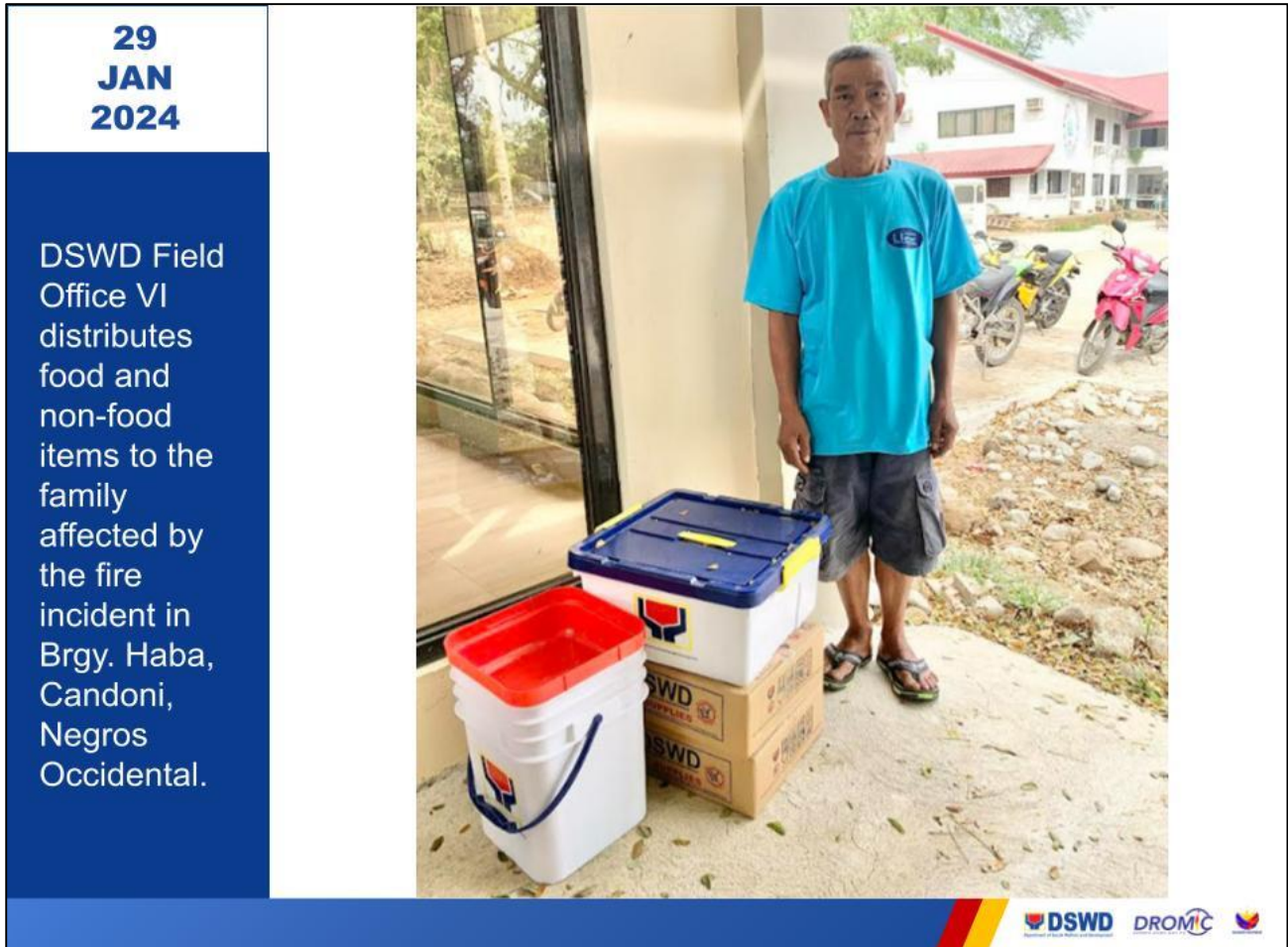
