



DSWD DROMIC Report on the Fire Incident in Brgy. Haba, Condoni, Negros Occidental

03 February 2024, 6PM

I. Situation Overview

On 28 January 2024 at around 7AM, a fire incident occurred in Brgy. Haba, Condoni, Negros Occidental. According to the Bureau of Fire Protection (BFP), the cause of fire was allegedly due to faulty electrical wire. The fire was declared out at around 8:48 AM.

II. Status of Affected Areas and Population

One (1) family or four (4) persons were affected in Brgy. Haba, Condoni, Negros Occidental (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or **four (4) persons** temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Haba, Condoni, Negros Occidental** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱9,438.00 worth of assistance was provided to the affected families; of which, ₱4,438.00 from DSWD and ₱5,000.00 from the Local Government Unit (LGU) (see Annex D).


