

DSWD DROMIC Report on the Fire Incident in Brgy. Jaguimitan, Passi City, Iloilo

26 February 2024, 6AM

I. Situation Overview

On 25 September 2023 at around 7:00 PM, a fire incident occurred at Sitio Afga, Brgy. Jaguimitan, Passi City, Iloilo.

Relative to the incident, the DSWD through its Field office in Region VI, provided relief assistance to support the immediate needs of the affected family.
