19 February 2024, 6AM

I. Situation Overview

On 03 February 2024 at around 1:00 PM, a fire incident occurred in Brgy. Lanot, Roxas City, Capiz. The fire was declared out at around 1:35 PM.

Relative to the incident, the DSWD through its Field Office in Region VI provided relief goods to support the immediate needs of the affected families and individuals.
