### **I. Situation Overview**

On 08 February 2024 at around 3:12 PM, a fire incident occurred in Brgy. Mandalagan, Bacolod City. The fire was declared out at around 4:20 PM.

**One (1) house** was **totally damaged** in **Brgy. Mandalagan, Bacolod City** (see Annex C).

### **V. Cost of Humanitarian Assistance Provided**

A total of **₱13,435.78** worth of assistance was provided to the affected families; of which, **₱8,435.78** from **DSWD** and **₱5,000.00** from the **Local Government Unit (LGU)** (see Annex D).
