On 30 January 2024 at around 11:42 AM, a fire incident occurred in Brgy. Mantulang, City of Passi, Iloilo. The fire was declared out at around 12:30 PM.

A total of ₱18,146.00 worth of assistance was provided to the affected family; of which, ₱8,146.00 from DSWD and ₱10,000.00 from the Local Government Unit (LGU) (see Annex D).
