I. Situation Overview

On 19 February 2024 at around 2:00 PM, a fire incident occurred at Brgy. Nasuli, Maasin, Iloilo. The fire was declared out at around 2:50 PM.

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Nasuli, Maasin, Iloilo** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱3,408.00** worth of assistance was provided to the affected families; of which, **₱3,108.00** from **DSWD** and **₱300.00** from the **Local Government Unit (LGU)** (see Annex D).
