

DSWD DROMIC Report on the Fire Incident in Brgy. Paypayon, Oras, Eastern Samar

10 February 2024, 6PM

I. Situation Overview

On 29 January 2024 at around 10:04 AM, a fire incident occurred at Brgy. Paypayon, Oras, Eastern Samar. Fire out was declared at around 10:40 AM.

Relative to the incident, the DSWD through its Field Office in Region VIII provided relief goods to support the immediate needs of affected family.

One (1) family or three (3) persons temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Paypayon, Oras, Eastern Samar** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱8,153.29** worth of assistance was provided by **DSWD** to the affected family (see Annex D).
