

## **DSWD DROMIC Report on the Fire Incident in Brgy. Riverside, Isabela, Negros Occidental**

03 February 2023, 6AM

### **I. Situation Overview**

On 25 January 2024 at around 3:20 PM, a fire incident occurred in Brgy. Riverside, Isabela, Negros Occidental. The fire was declared out at around 4:48 PM.

In response, the DSWD through its Field Office in Region VI and the Local Government Unit (LGU) of Isabela, Negros Occidental, provided relief assistance to support the immediate needs of the affected families and individuals.

**One (1) family** or **three (3) persons** were affected in **Brgy. Riverside, Isabela, Negros Occidental** (see Annex A).

**One (1) family** or **three (3) persons** temporarily stayed with their relatives (see Annex B).

### **IV. Damaged Houses**

**One (1) house** was **totally damaged** in **Brgy. Riverside, Isabela, Negros Occidental** (see Annex C).

### **V. Cost of Humanitarian Assistance Provided**

A total of **₱10,308.00** worth of assistance was provided to the affected families; composed of **₱5,308.00** from **DSWD** and **₱5,000.00** from the **Local Government Unit (LGU)** (see Annex D).
