

DSWD DROMIC Report on the Fire Incident in Brgy. Sag-ang, La Castellana, Negros Occidental

22 February 2024, 6PM

I. Situation Overview

On 01 January 2024 at around 1:45 PM, a fire incident occurred at Sitio Pacita, Brgy. Sag-ang, La Castellana, Negros Occidental. The fire was declared out at around 2:53 PM.

One (1) family or five (5) persons were affected in **Brgy. Sag-ang, La Castellana, Negros Occidental** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or five (5) persons temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Sag-ang, La Castellana, Negros Occidental** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱11,937.78** worth of assistance was provided to the affected families; of which, **₱6,937.78** from **DSWD** and **₱5,000.00** from the **Local Government Unit (LGU)** (see Annex D).
