I. Situation Overview

On 11 January 2024 at around 8:07 AM, a fire incident occurred in Brgy. Sambag Jaro, Iloilo City. The fire was declared out at around 8:33 AM.

II. Status of Affected Areas and Population

A total of **four (4) families** or **22 persons** were affected in **Brgy. Sambag Jaro, Iloilo City** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of **four (4) families** or **22 persons** temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

A total of **four (4) houses** were damaged; of which, **two (2)** are **totally damaged** and **two (2)** are **partially damaged** in **Brgy. Sambag Jaro, Iloilo City** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱43,657.18** worth of assistance was provided to the affected families; of which, **₱26,248.00** from **DSWD** and **₱17,409.18** from the **Local Government Unit (LGU)** (see Annex D).
