

DSWD DROMIC Report on the Fire Incident in Brgy. Saraet, Himamaylan City, Negros Occidental

17 February 2024, 6AM

I. Situation Overview

On 14 February 2024 at around 1PM, a fire incident occurred in Brgy. Saraet, Himamaylan City, Negros Occidental. The fire was declared out at around 2:18 PM.

In response, the DSWD through its Field Office in Region VI provided relief assistance to support the immediate needs of the affected family.

II. Status of Affected Areas and Population

One (1) family or three (3) persons were affected in **Brgy. Saraet, Himamaylan City, Negros Occidental** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or three (3) persons temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Saraet, Himamaylan City, Negros Occidental** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱13,586.00** worth of assistance was provided to the affected family; of which, **₱8,586.00** from **DSWD** and **₱5,000.00** from the **Local Government Unit (LGU)** (see Annex D).
