





DSWD DROMIC Report on the Fire Incident in Brgy. South Fundidor, Iloilo City

05 February 2024, 6AM

I. Situation Overview

On 19 January 2024 at around 3:34 PM, a fire incident occurred at Garrison Street Zone 4, Brgy. South Fundidor, Molo, Iloilo City. The fire was declared out at around 4:18 PM.

II. Status of Affected Areas and Population

A total of five (5) families or 12 persons were affected in Brgy. South Fundidor, Iloilo City (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of **five (5) families** or **12 persons** temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

A total of three (3) houses were totally damaged in Brgy. South Fundidor, Iloilo City (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **P52,527.90** worth of assistance was provided to the affected families; of which, **P32,810.00** from **DSWD** and **P19,717.90** from the **Local Government Unit (LGU)** (see Annex D).
