





DSWD DROMIC Report on the Fire Incident in Brgy. Tabugon, Kabankalan City, Negros Occidental

27 February 2024, 6AM

I. Situation Overview

On 02 February 2024 at around 5:03 PM, a fire incident occurred in Brgy. Tabugon, Kabankalan City, Negros Occidental. The fire was declared out at around 6:25 PM.

Consequently, the incident has led to displacement of a family comprise of four (4) individuals with their house engulfed by the fire. Relative to the incident, the DSWD through its Field Office in Region VI, together with the Local Government Unit (LGU) of Kabankalan City, Negros Occidental, provided relief assistance to support the immediate needs of the affected family.

II. Status of Affected Areas and Population

One (1) family or four (4) persons were affected in Brgy. Tabugon, Kabankalan City, Negros Occidental (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center
One (1) family or four (4) persons temporarily stayed with their relative (see Annex B).

IV. Damaged Houses

One (1) house was totally damaged in Brgy. Tabugon, Kabankalan City, Negros Occidental (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **P13,416.00** worth of assistance was provided to the affected family; composed of **P8,416.00** from **DSWD** and **P5,000.00** from the **Local Government Unit** (**LGU**) (see Annex D).
