I. Situation Overview

On 14 February 2024 at around 8:30 AM, a fire incident occurred in Brgy. Tagudtud South, Bugasong, Antique.

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Tagudtud South, Bugasong, Antique** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱13,425.78.00** worth of assistance was provided to the affected families; of which, **₱8,425.78** from **DSWD** and **₱5,000.00** from the **Local Government Unit (LGU)** (see Annex D).
