





# DSWD DROMIC Report on the Fire Incident in Brgy. Tampalon, Kabankalan City, Negros Occidental

27 February 2024, 6AM

#### I. Situation Overview

On 15 February 2024 at around 11:00 AM, a fire incident occurred in Brgy. Tampalon, Kabankalan City, Negros Occidental. The fire was declared out at around 12:10 PM.

The incident has led to displacement of a family, leaving their house engulfed by the fire. In response, the DSWD through its Field Office in Region VI, together with the Local Government Unit (LGU) of Kabankalan City, provided relief assistance to support the immediate needs of the affected family.

One (1) house was totally damaged in Brgy. Tampalon, Kabankalan City, Negros Occidental (see Annex C).

#### V. Cost of Humanitarian Assistance Provided

A total of **₱13,416.00** worth of assistance was provided to the affected family; composed of, **₱8,416.00** from **DSWD** and **₱5,000.00** from the **Local Government Unit (LGU)** (see Annex D).
