



DSWD DROMIC Report on the Fire Incident in Brgy. Tinongan, Isabela, Negros Occidental

03 February 2024, 6AM

I. Situation Overview

On 24 January 2024 at around 2:10 PM, a fire incident occurred in Brgy. Tinongan, Isabela, Negros Occidental, and was declared fire out at 3:43 PM.

As per validation of the Municipal Social Welfare and Development Office (MSWDO) of Isabela, the affected family already transferred to a new house within the same barangay.

In response, the DSWD through its Field Office in Region VI and the Local Government Unit (LGU) of Isabela, provided relief assistance to support the immediate needs of the affected families and individuals.

II. Status of Affected Areas and Population

One (1) family or **five (5) persons** were affected in **Brgy. Tinongan, Isabela, Negros Occidental** (see Annex A).

III. Damaged Houses

One (1) house was totally damaged in Brgy. Tinongan, Isabela, Negros Occidental (see Annex B).

IV. Cost of Humanitarian Assistance Provided

A total of ₱10,308.00 worth of assistance was provided to the affected families; composed of ₱5,308.00 from DSWD and ₱5,000.00 from the Local Government Unit (LGU) (see Annex C).
