

DSWD DROMIC Report on the Fire Incident in Brgy. Tonton, Lingayen, Pangasinan

23 February 2024, 6AM

I. Situation Overview

On 27 November 2021 at around 6:46 PM, a fire incident occurred at Brgy. Tonton, Lingayen, Pangasinan.

II. Status of Affected Areas and Population

A total of **eight (8) families** or **40 persons** were affected in **Brgy. Tonton, Lingayen, Pangasinan** (see Annex A).

III. Status of Displaced Population

Inside Evacuation Center

A total of **eight (8) families** or **40 persons** sought temporarily shelter at the **Tonton Barangay Hall** in **Brgy. Tonton, Lingayen, Pangasinan** (see Annex B).

IV. Damaged Houses

A total of **four (4) houses** were **totally damaged** in **Brgy. Tonton, Lingayen, Pangasinan** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱114,931.76** worth of assistance was provided to the affected families; of which, **₱64,981.76** from **DSWD**, and **₱49,950.00** from the **Local Government Unit (LGU)** (see Annex D).
