I. Situation Overview

On 16 December 2023 at around 6:27 PM, a fire incident occurred in Brgy. Ubojan, Loon, Bohol. The fire was declared out at around 8:05 PM.

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Ubojan, Loon, Bohol** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱11,799.30** worth of assistance was provided to the affected families; of which, **₱6,799.30** from **DSWD** and **₱5,000.00** from the **Local Government Unit (LGU)** (see Annex D).
