I. Situation Overview

On 29 January 2024 at around 10:00 AM, a fire incident occurred in Brgy. Uhaj, Banaue, Ifugao.

One (1) family or **four (4) persons** were affected in **Brgy. Uhaj, Banaue, Ifugao** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or **four (4) persons** temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was totally damaged in Brgy. Uhaj, Banaue, Ifugao (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱18,629.03 worth of assistance was provided to the affected families; of which, ₱10,629.03 from DSWD and ₱8,000.00 from the Local Government Unit (LGU) (see Annex D).
