

# DSWD DROMIC Terminal Report on the Armed Conflict in Brgy. Mahayag, Sta. Margarita, Western Samar

18 February 2024, 6PM

## I. Situation Overview

On 30 January 2024, an armed conflict between the alleged members of an unknown armed group and the government troops (Philippine Army and Philippine National Police) occurred in Brgy. Mahayag, Sta. Margarita, Western Samar. This incident resulted in the displacement families and individuals in the area.
