

DSWD DROMIC Terminal Report on the Armed Conflict in Brgy. Palanggalan, Carmen, North Cotabato

29 January 2025, 6AM

I. Situation Overview

On 15 February 2024 at around 6:00 AM, an armed conflict between the warring groups of Commander Teo Manalimbong of MILF 105th Base Command and Mohammed Saladuhin of NG-MILF occurred at Sitio Marmal, Barangay Palanggalan, Carmen, North Cotabato resulting to the displacement of families in the area.

The incident has led to displacement of families and individuals in the community. In response, the DSWD through its Field Office in Region XII promptly provided relief aid to support the immediate needs of the affected populace.

A total of **1,643 families or 8,215 persons** were affected in **Brgy. Palanggalan, Carmen, North Cotabato** (see Annex A).

III. Status of Displaced Population

Inside Evacuation Center

A total **1,643 families or 8,215 persons** sought temporary shelter in **three (3) evacuation centers** in **Barangay Palanggalan, Carmen, North Cotabato** (see Annex B).

IV. Cost of Humanitarian Assistance Provided

A total of **₱688,275.00** worth of assistance was provided by **DSWD** to the affected families (see Annex C).
