### I. Situation Overview

On 23 January 2024 at around 5:27 PM, a fire incident occurred in Brgy. Bogasong, Libagon, Southern Leyte.

Inside Evacuation Center One (1) family or six (6) persons sought temporary shelter at the Brgy. Bogasong Hall in Libagon, Southern Leyte (see Annex B).

#### IV. Damaged Houses

**One (1) house** was **totally damaged** in **Brgy. Bogasong, Libagon, Southern Leyte** (see Annex D).

## V. Cost of Humanitarian Assistance Provided

A total of ₱52,568.50 worth of assistance was provided to the affected family; of which, ₱17,861.50 from DSWD and ₱34,707.00 from the Local Government Unit (LGU) (see Annex E).
