I. Situation Overview

On 08 February 2024 at around 1:45 PM, a fire incident occurred in Brgy. Bololacao, New Lucena, Iloilo. The fire was declared out at around 3:00 PM.

IV. Damaged Houses

A total of **six (6) houses** were damaged; of which, **one (1) is totally damaged** and **five (5) are partially damaged** in **Brgy. Bololacao, New Lucena, Iloilo** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱42,660.00** worth of assistance was provided by **DSWD** to the affected families (see Annex D).
