

DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Daan Banua, Kabankalan City, Negros Occidental

08 June 2024, 6PM

I. Situation Overview

On 25 January 2024 at around 6:20 PM, a fire incident occurred in Brgy. Daan Banua, Kabankalan City, Negros Occidental. The fire was declared out at around 7:35 PM.

In response, the DSWD through its Field Office in Region VI together with the Local Government Unit (LGU) of Kabankalan City, promptly provided relief assistance to support the immediate needs of the affected family.

One (1) family or two (2) persons were affected in **Brgy. Daan Banua, Kabankalan City, Negros Occidental** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or two (2) persons temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Daan Banua, Kabankalan City, Negros Occidental** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱10,835.78** worth of assistance was provided to the affected family composed of **₱8,335.78** from **DSWD** and **₱2,500.00** from the **Local Government Unit (LGU)** (see Annex D).
