





DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Gumaga, Libungan, North Cotabato

11 February 2024, 6AM

I. Situation Overview

On 24 November 2023 at around 4:15 PM, a fire incident occurred in Brgy. Gumaga, Libungan, North Cotabato.

Relative to the incident, the DSWD through its Field Office in Region XII, provided intervention to support the immediate needs of affected families and individuals by means of relief assistance.
