

# DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Kauswagan, Cagayan de Oro City, Misamis Oriental

10 February 2024, 6PM

## I. Situation Overview

On 04 February 2023 at around 8:55 AM, a fire incident occurred at Kingfisher St., Zone 2, Brgy. Kauswagan, Cagayan de Oro City, Misamis Oriental. The fire was declared out at around 9:30 AM.

In Response, the DSWD through its Field Office in Region X together with the LGU of Cagayan de Oro City, provided relief assistance to support the immediate needs of affected family.
