I. Situation Overview

On 14 February 2024 at around 10:20 AM, a fire incident occurred at Purok Katarungan Zone 1, Brgy. San Miguel, Puerto Princesa City, Palawan. The fire was declared out at around 11:30 AM.

A total of **20 families** or **63 persons** sought temporary shelter at the **Brgy. Rural Health Center** in **Brgy. San Miguel, Puerto Princesa City, Palawan** (see Annex B).

IV. Damaged Houses

A total of **10 houses** were damaged; of which, **seven (7)** are **totally damaged** and **three (3)** are **partially damaged** in **Brgy. San Miguel, Puerto Princesa City, Palawan** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱259,628.05** worth of assistance was provided by **DSWD** to the affected families (see Annex D).
