

DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Tingub, Mandaue City, Cebu

I. Situation Overview

On 03 February 2024 at around 8:05 PM, a fire incident occurred in Brgy. Tingub, Mandaue City, Cebu. The fire was declared out at around 8:58 PM.

II. Status of Affected Areas and Population

A total of **81 families** or **230 persons** were affected in **Brgy. Tingub, Mandaue City, Cebu** (see Annex A).

III. Status of Displaced Population

Inside Evacuation Center

A total of **81 families** or **230 persons** sought temporary shelter in **Tingub Elementary School** in **Brgy. Tingub, Mandaue City, Cebu** (see Annex B).

IV. Damaged Houses

A total of **28 houses** were damaged; of which, **25 are totally damaged** and **three (3) are partially damaged** in **Brgy. Tingub, Mandaue City, Cebu** (see Annex D).

V. Cost of Humanitarian Assistance Provided

A total of **₱2,264,013.80** worth of assistance was provided to the affected families; of which, **₱994,063.80** from **DSWD** and **₱1,269,950.00** from the **Local Government Unit (LGU)** (see Annex E).
