

DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Tisa, Cebu City

26 January 2025, 6PM

I. Situation Overview

On 05 February 2024 at around 9:15 AM, a fire incident occurred in Brgy. Tisa, Cebu City. The fire was declared out at around 9:50 AM.

II. Status of Affected Areas and Population

A total of **20 families** or **86 persons** were affected in **Brgy. Tisa, Cebu City** (see Annex A).

III. Status of Displaced Population

Inside Evacuation Center

A total of **20 families** or **86 persons** sought temporary shelter at the **Tisa National High School** in **Brgy. Tisa, Cebu City** (see Annex B).

IV. Damaged Houses

A total of 15 houses were damaged; of which, 10 are totally damaged and five (5) are partially damaged in Brgy. Tisa, Cebu City (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱677,779.00 worth of assistance was provided by the Local Government Unit (LGU) to the affected families (see Annex D).
