

DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Upper Balulang, Cagayan de Oro City, Misamis Oriental

10 February 2024, 6PM

I. Situation Overview

On 11 February 2023 at around 1:05 PM, a fire incident occurred at Blk-1, Lot 5, Xavier Heights, Brgy. Upper Balulang, Cagayan de Oro City, Misamis Oriental.

Relative to the incident, the DSWD through its Field Office in Region X together with the LGU of Cagayan de Oro City, promptly provided relief assistance to support the immediate needs of affected family.
