

## DSWD DROMIC Report #1 on the Fire Incident in Brgy. 256, Tondo, Manila City as of 27 February 2024, 6PM

### I. Situation Overview

On 26 February 2024 at around 1:15 AM, a fire incident occurred at Villaruel St., 1816 Tecson de Guia, Brgy. 256, Tondo, Manila City. The fire was declared out at around 2:24 AM.

### II. Status of Affected Areas and Population

A total of **32 families** or **104 persons** are affected in **Brgy. 256, Tondo, Manila City** (see Annex A).

### III. Status of Displaced Population

#### Outside Evacuation Center

There are **32 families** or **104 persons** temporarily staying with their relatives or friends (see Annex B).

### IV. Damaged Houses

A total of **six (6) houses** were damaged; of which, **five (5)** are **totally damaged** and **one (1)** is **partially damaged** in **Brgy. 256, Tondo, Manila City** (see Annex C).
