

## DSWD DROMIC Report #1 on the Fire Incident in Brgy. Ponong, Carigara, Leyte as of 15 March 2024, 6AM

### I. Situation Overview

On 29 February 2024 at around 5:30 AM, a fire incident occurred at Brgy. Ponong, Carigara, Leyte.

A total of **five (5) families** or **16 persons** are affected in **Brgy. Ponong, Carigara, Leyte** (see Annex A).

### III. Status of Displaced Population

#### Outside Evacuation Center

There are **five (5) families** or **16 persons** temporarily staying with their relatives or friends (see Annex B).

### IV. Damaged Houses

A total of **four (4) houses** were damaged; of which, **one (1) totally damaged** and **three (3) are partially damaged** in **Brgy. Ponong, Carigara, Leyte** (see Annex C).

### V. Cost of Humanitarian Assistance Provided

A total of **₱40,507.70** worth of assistance was provided by **DSWD** to the affected families (see Annex D).
