





DSWD DROMIC Report #1 on the Fire Incident in Brgy. Tabing, Tabango, Leyte

as of 28 March 2024, 6AM

I. Situation Overview

On 22 March 2024 at around 11:00 AM, a fire incident occurred in Brgy. Tabing, Tabango, Leyte.

Relative to the incident, the DSWD through its Field Office in Region VIII, together with the Local Government Unit (LGU) of Tabango, Leyte, provided relief augmentation and financial assistance to support the immediate needs of the affected families and individuals

II. Status of Affected Areas and Population

A total of two (2) families or six (6) persons are affected in Brgy. Tabing in Tabango, Leyte (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

There are two (2) families or six (6) persons temporarily staying with their relatives (see Annex B).

IV. Damaged Houses

A total of two (2) houses were totally damaged in Brgy. Tabing, Tabango, Leyte (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of \$\mathbb{P}46,452.00\$ worth of assistance was provided to the affected families composed of \$\mathbb{P}36,452.00\$ from DSWD and \$\mathbb{P}10,000.00\$ from the Local Government Unit (LGU) (see Annex D).
