



DSWD DROMIC Report #6 on the Fire Incident in Brgy. Looc, Mandaue City, Cebu

as of 29 March 2024, 6AM

I. Situation Overview

On 12 March 2024 at around 12:06 PM, a fire incident occurred in Brgy. Looc, Mandaue City, Cebu. The fire was declared out at around 2:16 PM.

In response, the DSWD through its Field Office in Region VII, together with the Local Government Unit (LGU) of Mandaue City, provided relief augmentation and financial assistance to support the immediate needs of the affected families and individuals.

II. Status of Affected Areas and Population

A total of **515 families** or **1,677 persons** are affected in **Brgy. Looc, Mandaue City, Cebu** (see Annex A).

III. Status of Displaced Population

Inside Evacuation Center

There are **515 families** or **1,677 persons** currently taking temporary shelter at the **Cesar M. Cabahug Elementary School** in **Brgy. Looc, Mandaue City, Cebu** (see Annex B).

IV. Damaged Houses

A total of **370 houses** were damaged; of which, **357** are **totally damaged** and **13** are **partially damaged** in **Brgy. Looc, Mandaue City, Cebu** (see Annex E).

V. Cost of Humanitarian Assistance Provided

A total of **₱28,705,388.80** worth of assistance was provided to the affected families composed of **₱10,105,388.80** from the **DSWD** and **₱18,600,000.00** from the **Local Government Unit (LGU)** (see Annex F).
