

DSWD DROMIC Report on the Fire Incident in Brgy. Antipolo, Pontevedra, Negros Occidental

05 March 2024, 6AM

I. Situation Overview

On 7 February 2024 at around 11:30 AM, a fire incident occurred at Brgy. Antipolo, Pontevedra, Negros Occidental due to faulty electrical wire. The fire was declared out at around 12:25 PM.

Relative to the incident, the DSWD through its Field Office in Region VI, together with the Local Government Unit (LGU) of Pontevedra, provided relief augmentation to support the immediate needs of the affected family.

II. Status of Affected Areas and Population

One (1) family or one (1) person was affected in **Brgy. Antipolo, Pontevedra, Negros Occidental**. (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or one (1) person temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Antipolo, Pontevedra, Negros Occidental**. (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱13,425.78** worth of assistance was provided to the affected family; composed of **₱8,425.78** from **DSWD** and **₱5,000.00** from the **Local Government Unit (LGU)** (see Annex D).
