

## **DSWD DROMIC Report on the Fire Incident in Brgy. Bacong-Montilla, Bago City, Negros Occidental**

05 March 2024, 6AM

### **I. Situation Overview**

On 29 February 2024 at around 10:00 AM, a fire incident Brgy. Bacong-Montilla, Bago City, Negros Occidental, due to a faulty electrical wire. The fire was declared out at around 11:18 AM.

In response to the incident, the DSWD through its Field Office in Region VI together with the LGU of Bago City, promptly provided intervention to support the immediate needs of the affected family.

### **IV. Damaged Houses**

**One (1) house** was **totally damaged** in **Brgy. Bacong-Montilla, Bago City, Negros Occidental** (see Annex C).

### **V. Cost of Humanitarian Assistance Provided**

A total of **₱32,368.00** worth of assistance was provided to the affected family composed of **₱20,568.00** from **DSWD** and **₱11,800.00** from the **Local Government Unit (LGU)** (see Annex D).
