

DSWD DROMIC Report on the Fire Incident in Brgy. Balili, Mankayan, Benguet

16 March 2024, 6AM

I. Situation Overview

On 17 February 2024 at around 8:37 PM, a fire incident occurred at Brgy. Balili, Mankayan, Benguet.

II. Status of Affected Areas and Population

A total of **four (4) families** or **16 persons** were affected in **Brgy. Balili, Mankayan, Benguet** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of **three (3) families** or **15 persons** temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

A total of **two (2) houses** were damaged; of which, **one (1) is totally damaged** and **one (1) is partially damaged** in **Brgy. Balili, Mankayan, Benguet** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱64,839.98.00** worth of assistance was provided to the affected families; of which, **₱53,000.00** from **DSWD** and **₱11,839.98.00** from the **Local Government Unit (LGU)** (see Annex D).
