

## **DSWD DROMIC Report on the Fire Incident in Brgy. Batobato, Libacao, Aklan**

01 March 2024, 6PM

### **I. Situation Overview**

On 27 February 2024 at around 11:00 AM, a fire incident occurred at Sitio Caeamiga, Brgy. Batobato, Libacao, Aklan. The fire was declared out at around 11:30 AM.

**One (1) family** or **four (4) persons** were affected in **Brgy. Batobato, Libacao, Aklan** (see Annex A).

**One (1) family** or **four (4) persons** temporarily stayed with their relatives or friends (see Annex B).

### **IV. Damaged Houses**

**One (1) house** was totally damaged in **Brgy. Batobato, Libacao, Aklan** (see Annex C).

### **V. Cost of Humanitarian Assistance Provided**

A total of **₱10,916.00** worth of assistance was provided to the affected families; of which, **₱8,416.00** from **DSWD** and **₱2,500.00** from the **Local Government Unit (LGU)** (see Annex D).
